

Terms and Conditions for ROBIZ3190 - RI District 3190 Initiative

This document represents the Terms and Conditions for the use of the mobile application "ROBIZ 3190" provided by Niftrix Technologies Private Limited, Karnataka, India. By accessing or using the App, you agree to be bound by these Terms. If you do not agree with any part of these Terms, please refrain from using the App.

1. Acceptance of Terms

To use the Services, you agree that: (1) you are a Rotary member; (2) you will only have one ROBIZ 3190 account, which must be in your real name; and (3) you are not already restricted by Rotary from using the Services. Creating an account with false information is a violation of our terms, including accounts registered on behalf of others or persons under the age of 18.
